# Another Winning Season at Bama

\$1,646,901 Raised for the Capital Campaign Additional \$353,099 Needed to Reach our Goal

- Delta Theta Earns Knox and Sisson Awards at National Convention
- Chapter Maintains Strong Academic Standing

#### **Delta Theta Wins Prestigious Awards at Convention**

We've started another winning season at The University of Alabama, which began at the National Convention in August. Delta Theta won its second consecutive John Riley Knox Chapter of Excellence Award and third consecutive Francis H. Sisson Award. To put this in perspective, Beta Theta Pi has 119 chapters in the U.S. and Canada. Only eight won Knox awards, putting us in the top 7% internationally. Only 40 chapters have won Sisson awards.

#### **Chapter Ranks in Top Six for Academics**

Last year, Delta Theta's academics were excellent. The undergraduates earned over a 3.0 G.P.A. during the spring semester. Their strong academic standing placed them in the top six out of 31 fraternities on campus.

# **Chapter House Receives New Back Porch and Refinished Flooring**

To continue Delta Theta's winning tradition, the House Corporation has constructed a back porch and refinished the floors in the dining room, hallways, television room, stairwells, and common areas. These improvements were done

completely with donated funds. The final bills are still coming in, but we anticipate the cost of these improvements to be \$150,000. Thanks to the hard work of the construction committee, Dan Copeland '75,  $\Delta\Theta$  257, Bill Owen '71,  $\Delta\Theta$  174, and Jim McGriff '67,  $\Delta\Theta$  90, we were able to reduce the cost of the back porch and use that savings to refinish the floors.


#### Thank-You Alumni and Friends for Help During Recruitment


