# A President's Thoughts

I am very pleased to report that the great individual and chapter efforts that produced prestigious awards at the Greek Excellence Banquet were carried over into the 2013 Southeast Regional Keystone Conference for Beta Theta Pi. A portion of our chapter's executive members represented Delta Theta in Jacksonville, Florida at Keystone where we brought back an award recognizing our chapter's ability to self-govern. The Keystone Conference allowed our executive committee to gage our chapter's current state and produce goals for our chapter to improve our position on campus and among other chapters. Our main focus at Keystone was addressing the inactive culture among our members in order to strive for a high retention rate of enrolled four year active members. Our executive members and chapter have already voted in a formal inactive process to our by-laws that formally defines active/inactive obligations. We as a chapter are enforcing the rules upon those inactive members. To increase the retention rate, we are taking our focus towards the process of recruiting new members and instilling in those members the importance of active status as well as its positive impact on the chapter and our University.

Our second cumulative goal was to improve our overall chapter GPA to that of one above the overall undergraduate average. Our chapter GPA has improved year by year for the last two years, but we remained slightly below the overall undergraduate average mark. We as a chapter take this goal very seriously because the GPA requirements for the Know Award are demanding. We strive to meet them through increasing the term GPA minimum in our Academic Assistance Plan. The redefined AAP keeps members accountable. A recorded below-par term GPA as requires a member to complete mandatory study hall hours and is accompanied by possible social probation. We as a chapter are also stressing the importance of our New Members' GPA's. Alex Ash, the New Member Educator, has a personal goal of a New Member GPA above 3.0 which will be made obtainable through the Pledge Progress Report System. These progress reports will monitor the new members' attendance and grades throughout their pledgeship to ensure they are attending class and making good grades.

Our final, yet very important, goal was improving the overall relationship between our valuable alumni and our current active members. As a chapter, we are striving for an electronic and accurate active roster of our alumni that is easily accessible. Upcoming events and announcements can be sent out via email through one, simple database that contains all of our active alumni. Our chapter is also interested in hosting an alumni networking event for upper classmen seeking future employment opportunities.

We know that with all of your continued support, our chapter goals can be reality as we work towards the continuous improvement of our chapter to become the best on campus and in the eyes of the General Fraternity.
